

# REFEREE COACH REACCREDITATION GUIDELINES (All Victorian Referee Coaches)

In order to update and or re-accredit, Referee Coaches they must in a defined period:



- New/upgrading/returning Referee coaches: Completing a Referee Coach Course accredits you for the remainder of the year of qualification year and the following year. In the subsequent year, you will be accumulating points for the next year.
- Currently qualified referee coaches will commence collecting reaccreditation points in 2017



## **Accumulating Points:**

This is can be done by a range of activities in two main areas: **Practical Referee Coaching** and **Identified Coaching Activities** 

Referee Coach Level	Practical Referee Coaching	Identified Coaching Activities	Total Points required	
Grade 1 (2018)	at least 15 (local level)	at least 5 (local level)	20	< Advisor Reaccredited
Grade 2	at least 15	at least 5	20	
Grade 3/4	at least 20	at least 10	30	<— Game details: Advisor/League Supplied

# **Practical Referee Coaching:**

Practical coaching can be undertaken with any level of game, and may occur on a regular basis in affiliated competitions or in approved tournaments or events sanctioned by TOC (VBRA).

The Practical Referee Coaching points can be obtained by:

- Self-monitored through personal/branch records (Evidence of Referee Coaching needs to be signed off / approved by the local referee advisor, when it occurs on domestic basketball competitions; details passed on to TOC Admin. officer)
- Information supplied by the relevant affiliated League/s that the coach operates in. Points to be allocated as follows:

Game observations or assessments	Domestic game	Approved Country Event	Approved Tournament	League Game
Points	1	1	1	2

## **Identified Coaching Activities:**

In two main areas as described in the tables:

Ongoing Coach Activities (Attendance at)	Points
approved League or Competition information sessions	2
approved education workshop sessions	2
Referee Advisor meetings	2

Ongoing Coach Activities (Involvement with)	Points
Advisor role	3
a mentoring role	2
presenting (or assisting) in a workshop session.	2
a National or International event	2
a significant contribution to creating education and training resource material	3
satisfactory completion of annual theory test (mandatory for ALL referee coaches)	3

## **Exemptions:**

Modifications to the reaccreditation process will be used in listed situations:

- 1. Association Advisors: Reaccreditation will be granted on the conditions listed:
- The annual Rules Test is satisfactorily completed.
- The advisor role must continue through the period of accreditation.
- Attendance is registered for at least 2 Referee Advisor meetings each year.
- 2. Referee Coaches in Elite Leagues: Reaccreditation will be granted on the conditions listed:
- The annual Rules Test is satisfactorily completed.
- Attendance is registered at the League Action day (one of multiple)
- The Referee Coach is included on a list to be provided by a League Appointments Officer, indicating satisfactory performance over the season.

## **Registering points:**

- game evaluations/observations advised to keep a personal list; ask your advisor (or referee supervisor) to provide a statement indicating the number of games you have done. These are to be forwarded to the TOC Admin Officer to be recorded.
- attendance/involvement:
  - we will enter details from attendance sheets at approved events (make sure you sign them !)
  - we will enter details from National Championships
  - YOU need to supply details re mentoring, attendance at external events

## Re-entry:

If a referee coach does not update their re-accreditation, they will cease to be an accredited referee coach unless they do either of the following;

- Repeat the appropriate Grade accreditation course.
- Provide a detailed submission to the TOC for dispensation from the re-accreditation requirements.
